

PARTICIPANT LIABILITY WAIVER, ASSUMPTION OF RISK & RELEASE

PLEASE READ THIS DOCUMENT CAREFULLY. BY SIGNING, YOU ACKNOWLEDGE THE RISKS ASSOCIATED WITH PARTICIPATING IN THIS OUTDOOR CAMPING EVENT AND AGREE TO THE TERMS BELOW.

1. VOLUNTARY PARTICIPATION & ASSUMPTION OF RISK

I understand that participation in the Tent or Treat Family Camp Weekend is voluntary and involves outdoor recreational and camping activities that carry inherent and other risks.

These risks may include, but are not limited to: uneven, wet, or slippery terrain; trips and falls; darkness and limited nighttime visibility; insects, ticks, snakes, and other wildlife; exposure to plants and allergens; changing or severe weather; rain, wind, heat, or cold; falling trees, branches, or other natural hazards; campfires, grills, and cooking equipment; burns and smoke exposure; hiking and other outdoor activities; recreational games and field-day activities; food-related illness or allergic reactions; interactions with other participants; and risks associated with camping and sleeping outdoors.

I understand that injuries may occur even when reasonable precautions are taken. I voluntarily choose to participate and knowingly assume the risks associated with my participation.

2. PARENT/GUARDIAN RESPONSIBILITY FOR MINORS

If I am registering or bringing a minor child, I represent that I am the child's parent, legal guardian, or otherwise legally authorized to consent to the child's participation.

I understand that **Pack It Up Getaways does not provide childcare or individual supervision of children**. I remain responsible for the supervision, safety, conduct, and whereabouts of every minor in my care throughout the entire event, including during organized activities, free time, nighttime activities, and while at the campsite.

I am responsible for determining whether each activity is appropriate for my child and understand that I or my child may choose not to participate in any activity.

3. HEALTH, MEDICAL NEEDS & EMERGENCY CARE

I am responsible for determining whether I and any minors in my care are physically able to participate safely in the event and its activities.

I agree to disclose relevant allergies, dietary restrictions, or other needs requested during registration and to bring any medications, medical devices, or other supplies that I or the minors in my care may require.

In the event of an emergency, I authorize Pack It Up Getaways representatives to contact emergency medical services when reasonably necessary. I understand that Pack It Up Getaways does not provide medical care and cannot guarantee the availability or response time of emergency personnel.

I accept financial responsibility for medical treatment, transportation, or other emergency services provided to me or a minor in my care.

4. PARTICIPANT RESPONSIBILITIES & PARK RULES

I agree to follow all applicable rules and regulations of Lake Houston Wilderness Park, as well as reasonable safety instructions provided by Pack It Up Getaways.

I understand that I am responsible for safely setting up, maintaining, securing, and using my own tent, sleeping equipment, cooking equipment, and other personal camping gear.

I understand that unsafe, disruptive, or prohibited conduct may result in a participant being asked to discontinue an activity or leave the event when reasonably necessary for participant safety or compliance with park requirements.

5. WEATHER & EVENT CHANGES

I understand that Tent or Treat is an outdoor event and that weather and outdoor conditions are unpredictable.

Activities, schedules, or locations within the event may be modified, postponed, or canceled because of weather, park restrictions, emergencies, safety concerns, or circumstances outside the reasonable control of Pack It Up Getaways.

I understand that the event is intended to proceed rain or shine unless conditions, park officials, or other circumstances require cancellation or modification.

6. PERSONAL PROPERTY

I am responsible for my own belongings, camping equipment, electronics, vehicles, and other personal property.

To the fullest extent permitted by law, Pack It Up Getaways is not responsible for personal property that is lost, stolen, misplaced, or damaged by weather, wildlife, other participants, or other circumstances outside the reasonable control of Pack It Up Getaways.

7. RELEASE OF LIABILITY — PLEASE READ CAREFULLY

TO THE FULLEST EXTENT PERMITTED BY TEXAS LAW, I RELEASE AND HOLD HARMLESS PACK IT UP GETAWAYS, ITS OWNERS, ORGANIZERS, REPRESENTATIVES, AGENTS, AND VOLUNTEERS FROM CLAIMS FOR PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE ARISING FROM MY PARTICIPATION IN THE EVENT, INCLUDING CLAIMS CAUSED BY THE ORDINARY NEGLIGENCE OF PACK IT UP GETAWAYS OR THE OTHER RELEASED PARTIES.

I UNDERSTAND THAT THIS RELEASE EXPRESSLY INCLUDES CLAIMS ALLEGING THAT PACK IT UP GETAWAYS OR ANOTHER RELEASED PARTY WAS NEGLIGENT.

THIS RELEASE DOES NOT APPLY TO LIABILITY THAT CANNOT LAWFULLY BE WAIVED OR RELEASED UNDER TEXAS LAW.

I understand that by signing this agreement, I am giving up certain legal rights on my own behalf.

8. PHOTOGRAPHY & VIDEO RELEASE

I understand that photographs and/or video recordings may be taken during the Tent or Treat Family Camp Weekend.

By signing this agreement, I grant Pack It Up Getaways permission to photograph and/or record me and any minor children I am authorized to register and to use those photographs or recordings for legitimate promotional, social media, advertising, and marketing purposes without compensation.

If I do not wish for myself or a minor child in my care to be photographed or recorded for promotional purposes, I understand that I must notify Pack It Up Getaways in writing prior to the event.

Pack It Up Getaways will make reasonable efforts to honor all written opt-out requests.

9. ACKNOWLEDGMENT

By signing below, I acknowledge that:

I have read this Participant Liability Waiver, Assumption of Risk & Release in its entirety; I understand its terms; I understand the nature of the activities and risks described above; I have had the opportunity to ask questions before participating; and I am signing voluntarily.
