

PACK IT UP GETAWAYS

DECK'D OUT CRUISES

Waiver, Release of Liability, Assumption of Risk & Participant Agreement

This agreement applies to participation in any **Deck'd Out** group cruise, related group activities, and associated travel experiences organized or coordinated by **Pack It Up Getaways ("PIUG")**.

By registering for, booking, paying for, or participating in a Deck'd Out cruise or related PIUG activity, I acknowledge and agree to the following:

1. VOLUNTARY PARTICIPATION & ASSUMPTION OF RISK

I understand that travel and participation in cruise-related and group activities are voluntary and may involve risks, including but not limited to illness, injury, accidents, slips and falls, transportation incidents, adverse weather, water-related activities, food-related illness, theft or loss of property, delays, cancellations, missed ports, itinerary changes, and other risks associated with travel and recreational activities.

I voluntarily assume all known and unknown risks associated with my participation and the participation of any minor children for whom I am legally authorized to accept this agreement.

2. ROLE OF PACK IT UP GETAWAYS

I understand that Pack It Up Getaways acts as a travel advisor and group organizer and does not own, operate, manage, or control cruise lines, cruise ships, airlines, hotels, ports of call, transportation companies, excursion operators, restaurants, attractions, entertainment providers, or other independent travel suppliers.

These independent suppliers are responsible for providing their respective services and may maintain their own terms, conditions, passenger contracts, cancellation policies, and liability waivers.

PIUG cannot guarantee or control the acts, omissions, safety procedures, schedules, operations, accommodations, services, itinerary changes, cancellations, delays, or performance of independent travel suppliers.

3. CRUISE LINE & TRAVEL SUPPLIER REQUIREMENTS

I understand that participation in a Deck'd Out cruise is subject to the applicable cruise line's passenger contract, policies, identification and travel-document requirements, health and safety requirements, and other terms and conditions.

I am responsible for reviewing and complying with all requirements applicable to my trip.

I understand that failure to possess required identification, passports, visas, or other required travel documentation may result in denied boarding or entry into a destination. PIUG is not responsible for losses resulting from my failure to satisfy applicable travel requirements.

4. PACK IT UP GETAWAYS GROUP ACTIVITIES

Deck'd Out cruises may include optional PIUG-organized activities such as group dinners, meet-and-greets, games, contests, scavenger hunts, field-day activities, parties, social gatherings, and other recreational activities.

Participation in these activities is voluntary.

I understand that some activities may involve physical movement or other inherent risks. I am responsible for determining whether I and any minors in my care are capable of safely participating.

I voluntarily assume the inherent risks associated with participation in these activities.

5. EXCURSIONS & OFF-SHIP ACTIVITIES

I understand that shore excursions and activities at destinations may be operated by the cruise line or independent third-party providers.

Unless expressly stated otherwise in writing, PIUG does not own, operate, supervise, or control these activities.

I am responsible for determining whether an excursion or activity is appropriate for myself and any minors traveling with me, including consideration of physical requirements, age restrictions, health considerations, and safety risks.

6. MINORS & PARENTAL RESPONSIBILITY

Parents and legal guardians remain solely responsible for the supervision, behavior, safety, and whereabouts of their minor children throughout the cruise, during travel, at ports of call, and during PIUG activities.

PIUG does not provide childcare, babysitting, or supervision of minors.

Participation in a group activity does not transfer responsibility for a minor to PIUG, its owner, representatives, contractors, volunteers, or other participants.

7. PERSONAL PROPERTY

I am responsible for safeguarding my luggage, identification, travel documents, money, electronics, jewelry, and other personal belongings.

To the fullest extent permitted by law, PIUG is not responsible for personal property that is lost, stolen, damaged, misplaced, or left behind during travel or participation in group activities.

8. MEDICAL CARE & EMERGENCIES

I understand that PIUG does not provide medical services and cannot guarantee the availability or quality of medical care aboard a vessel, at a destination, or during other travel activities.

I am responsible for considering my own medical needs and those of any minors traveling with me.

In an emergency involving me or a minor in my care, I authorize PIUG representatives to contact appropriate ship personnel, emergency services, or medical personnel when reasonably necessary.

I understand that I remain financially responsible for medical treatment, transportation, evacuation, or other services provided.

9. TRAVEL INSURANCE

I understand that travel insurance is strongly recommended and may provide protection for certain trip cancellations or interruptions, medical emergencies, evacuations, lost or delayed luggage, travel delays, or other covered circumstances.

I understand that declining travel insurance may leave me financially responsible for losses that might otherwise be covered by an applicable insurance policy.

10. RELEASE & LIMITATION OF LIABILITY

To the fullest extent permitted by applicable law, I release and hold harmless Pack It Up Getaways, its owner, employees, contractors, representatives, volunteers, and agents from claims arising from the ordinary and inherent risks of travel or voluntary participation in PIUG-organized activities, including claims arising from the acts or omissions of independent third-party travel suppliers.

This agreement is not intended to waive any right or claim that cannot legally be waived under applicable law or to exclude liability that applicable law prohibits PIUG from disclaiming.

11. PARTICIPANT CONDUCT

I agree to conduct myself and ensure that minors in my care conduct themselves in a respectful and safe manner.

All travelers remain subject to the rules, policies, and codes of conduct established by the applicable cruise line and other travel suppliers.

PIUG reserves the right to exclude a participant from PIUG-organized group activities when reasonably necessary because of dangerous, threatening, seriously disruptive, or inappropriate conduct.

Exclusion from a PIUG-organized activity does not constitute cancellation of the participant's cruise reservation and does not entitle the participant to reimbursement from PIUG for services provided by third parties.

12. PHOTOGRAPHY & MEDIA

Photography and video may occur during Deck'd Out cruises and group activities for event memories and Pack It Up Getaways promotional purposes.

By participating, I consent to the reasonable use of photographs or video containing myself and/or minors for whom I am legally authorized to provide consent, **unless I notify Pack It Up Getaways in writing that I do not consent to such use.**

PIUG will honor written requests not to use identifiable photographs or video of the participant for promotional purposes.

13. CHANGES BEYOND PIUG'S CONTROL

I understand that cruise itineraries, ports of call, schedules, transportation, accommodations, entertainment, excursions, activities, and other aspects of travel may change because of weather, mechanical issues, supplier decisions, government actions, emergencies, or other circumstances outside PIUG's control.

PIUG is not responsible for changes, cancellations, delays, substitutions, or other decisions made by independent travel suppliers.

14. ACKNOWLEDGMENT

By accepting this agreement, I acknowledge that:

- I have read and understand this Waiver, Release of Liability, Assumption of Risk & Participant Agreement.
- I understand that travel and recreational activities involve inherent risks.
- I understand that PIUG is a travel advisor and group organizer and that many travel services are provided by independent third parties.

- I voluntarily accept the terms of this agreement.
- I am legally authorized to accept these terms on behalf of any minor children included under my registration for whom I am signing.
- I have had the opportunity to ask questions before accepting this agreement.
